Publishing Group Inc., and the Defendants by Counterclaim, Danny Rosso and Christiane Tetreault, and of the Defendant and Plaintiff by Counterclaim, Tarwinder Shokar, judgment having been reserved to this day and costs having been reserved to June 16, 2015,
